Roosters doesn't hold a meeting at the beginning of the year to determine how much money it's going to donate to different causes.

The company and its namesake foundation prefer to see what needs surface and what causes move associates, said Nicole Cox, director of marketing and public

"We just give as the opportunities arise and to the people that mean a lot to us," she said.

One constant in the giving program is the Roosters Charitable Golf Outing, which last year raised \$100,000 for Buckeye Cruise.

Money donated to the cruise supports the Urban and Shelley Meyer Fund for Cancer Research that ultimately benefits the James Cancer Center and Solove Research Institute at Ohio State University, Cox said. Everyone in the organization feels good about supporting the James because so many people have been touched by cancer, she said.

The donations help researchers at the James look for cancer cures, wrote Dr. Michael Caligiuri, CEO of the hospital and research center director, in a letter thanking the foundation for its support.

"It enables us to research new ways to detect cancer at its earliest, most treatable stages," he wrote. "It helps us develop more effective, targeted treatments, and best yet, ways to predict, pre-empt and prevent it from occurring in the first place."

The organization's other annual giving program is the Roosters Fun Card Program, which benefits local schools, youth sports teams and nonprofit organizations. Organizations sell the cards – which give holders a 10 percent discount at Roosters for an entire year – for \$10. The sellers keep all of the profits from the card sales. The effort in 2014 raised \$800,000 for area nonprofits.
